# Eligibility Criteria

- 01 5 year integrated B.A. LL.B. (Hons.)**
  - **Educational Qualification:** 10+2 or equivalent;
  - **Passing Marks:** 55% marks for general candidates; 50% marks for candidates belonging to SC/ST category
- 02 3 year LL.B.**
  - **Educational Qualification:** Bachelor's degree in any discipline from a recognized University;
  - **Passing Marks:** 45% marks for general candidates; 40% marks for candidates belonging to SC/ST category
- 03 1 year LL.M.**
  - **Educational Qualification:** 3 years or 5 years Bachelor's degree in Law from a recognized University;
  - **Passing Marks:** 55% marks (or 6 CGPA on 10 point scale) for general candidates; 50% (or 5.5 CGPA on 10 point scale) marks for candidates belonging to SC/ST category

# Entrance Test

- Candidates must attend the SNLU Entrance Test to confirm admissions in undergraduate [B.A. LL.B.(H) & LL.B.] or postgraduate [LL.M.] programmes, respectively.
- Candidates must score minimum 50% marks (45% for SC/ST) in the SNLU Entrance Test.
- Candidates, who have appeared for CLAT 2026, shall be exempted from attending the entrance test. However, their CLAT score shall be taken into account while preparing the merit list.
