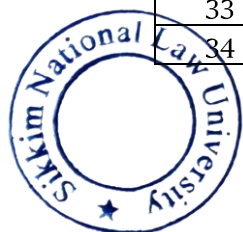

4. Transfer Certificate (TC) or School/College Leaving Certificate.
5. Character Certificate issued by the institution last attended.
6. Migration Certificate, wherever applicable.
7. Proof of Date of Birth.
8. Valid Photo Identity Proof (Aadhaar Card/Passport/Voter ID/Driving Licence).
9. Caste Certificate, if applicable.
10. Certificate of Identification / Residence Certificate, for Sikkimese students.
11. Recent passport-size colour photographs (five).
12. Copy of the SNLU Application Form.
13. Proof of payment of the Seat Booking Fee.
14. Any other document(s) as may be required by the University to establish eligibility.
