**ON-SPOT ADMISSION AGAINST VACANT SEATS IN
B.A. LL.B. (HONS.) PROGRAMME**

This is to inform all the concerned that Sikkim National Law University invites applications from eligible candidates for On-Spot Admission against the vacant seats in the B.A. LL.B. (Hons.) Programme. The On-Spot Admission Counselling shall be conducted through a thorough screening process, subject to the availability of seats and fulfilment of the eligibility criteria prescribed by the University.

Time: 11:00 A.M.

Venue: Sikkim Judicial Academy, Sokeythang, Lingding Road, Gangtok, Sikkim

All candidates desirous of seeking admission are required to report at the above-mentioned venue by 11:00 A.M. on 13 August 2026.

Eligibility: Candidates seeking admission to the B.A. LL.B. (Hons.) Programme must have secured a minimum of 55% marks in the 10+2 examination from a recognised Board/Institution.

Documents Required: Candidates are advised to report for counselling on the scheduled date and bring all original documents, along with one set of self-attested photocopies, for verification. The documents to be produced are as follows:

1. Class X (Secondary) Mark Sheet and Certificate (for proof of date of birth).
2. Class XII (Higher Secondary/Equivalent) Mark Sheet and Certificate.
3. Transfer Certificate (TC) or School/College Leaving Certificate.
4. Character Certificate issued by the institution last attended.
5. Migration Certificate, wherever applicable.
6. Proof of Date of Birth.
7. Valid Photo Identity Proof (Aadhaar Card/Passport/Voter ID/Driving Licence).
8. Recent passport-size colour photographs (five).

9. Any other document(s) as may be required by the University to establish eligibility.

Important Instructions:

- a) The On-Spot Admission process shall be conducted against the available vacant seats and shall be subject to a thorough screening process of the candidates appearing for admission.
- b) Admission shall be offered to eligible candidates based on the outcome of the screening process, availability of seats, and fulfilment of all eligibility requirements prescribed by the University.
- c) Candidates must produce all original documents, as prescribed, for verification at the time of the admission process.
- d) Candidates selected for admission shall be required to pay the prescribed admission fee on the same day, i.e., 13 August 2026, in order to confirm their admission.
- e) Failure to pay the prescribed admission fee on the date of admission shall result in forfeiture of the offered seat, and the University shall be at liberty to offer the seat to another eligible candidate.
- f) Mere reporting at the venue or participation in the On-Spot Admission process shall not guarantee admission.
- g) The University reserves the right to close the On-Spot Admission process once all available vacant seats are filled.
